Course Outline and Structure

Training Delivery

Training is delivered via **Blended (face to face + online distance) + Vocational Placement** to be completed in up to **52 Weeks (including holidays)** with approximately **1407 hours** of study, depending on learner's skills, knowledge, and experience. Prior to work placement and assessments, there will be face-to-face session/s for simulated workplace training.

What are the entry requirements?

There are no prerequisites required to enter this course. However, it is preferred that students:

- Are 16 years of age and over
- Have successfully completed at least Australian high school year 10, or equivalent
- Have basic computer skills
- Have sound Language, Literacy and Numeracy skills*
- Must have good general health and fitness for practicals
- Must have a National Police Clearance that does not have any disclosures that would impact them in gaining employment in the sector.
- Must understand their requirement to have an influenza vaccination and coronavirus vaccination prior to commencing placement

Assessment Methods:

- Observation during on-the-job or role play/simulation
- Questioning may include self-assessment, verbal answers, written questionnaires, activity modules or interview
- Third Party
- Structured activities may include projects, case studies, presentations, role play, demonstration, progressive tasks

As for certification considerations/requirements before work placement, the following listed will also be reviewed by Integrity RTO Solutions prior to enrolment:

- Working with Children Check
- Clear Police check (no older than 3 months)
- Current NDIS Check
- Current Working with Vulnerable People Check (WWVP) card (or evidence of application)

**Learners who do not meet the LLN requirements of the course may still enrol into the course provided the enrolment has been endorsed by the trainer and corresponding additional support strategies have been put in place.*

Vocational placement providers must allow access to:

- Vocational workplace supervisor(s) to supervise and confirm completion of the required tasks included in the Skills Workbook. The workplace supervisor must:
 - Have adequate knowledge and understanding of the provision of disability care
 - Have the ability to effectively supervise and manage disability care services
 - Have the necessary experience and qualification(s) in the area of individual support specialising in disability (e.g., you have the relevant VET qualification/s, Certificate III in Individual Support Specialising in Disability or higher)
- Clients' health information, including but are not limited to:
 - individualised plans (including information associated with the plans)
 - individualised behaviour support plans

Workplace Based Training and Simulation

VET students are required to undertake about 56 hours of workplace-based training and simulation within a registered and approved aged care centre prior to work placement.

Mandatory Vocational Placement

VET students are required to undertake a minimum of 120 hours of vocational placement within a registered and approved Community Services service. This must occur after the VET student has satisfactorily completed all the other units/subjects in this qualification.

During this time, the students are required to complete a skills workbook.

VET students have the option to:

- Source their own Vocational Placement providers (Integrity RTO Solutions to check suitability) or
- Have Integrity RTO Solutions assist them in arranging Vocational Placement providers near their area

Integrity RTO Solutions will continuously look for and form partnerships with Aged Care providers in the Northern Territory and in other states in the future.

Integrity RTO Solutions will provide VET students a Vocational Placement Pack that outlines all the requirements for finding a suitable Vocational Placement provider that will facilitate the required workplace assessments and allow the student to complete the required vocational placement hours.

- The Trainer/Assessor will travel from QLD to the workplace arrangements of the student in NT to deliver face-to-face and workplace assessments.

VET students are recommended to initiate contact with potential vocational placement providers as soon as enrolment is confirmed to allow sufficient time for Integrity RTO Solutions to confirm the workplace's safety and suitability.



Course Units

Comply with infection prevention and control policies and procedures (HLTINF006)

VET students must attend the online training session for HLTINF006 and complete the knowledge assessment before they go on vocational placement. Practical assessment tasks are to be completed during vocational placement.

Students to arrange access to:

- Computer/laptop with relevant software such as, but not limited to, the following:
 - internet access preferably through Google Chrome
 - MS Word and PowerPoint
 - Adobe Acrobat Reader
 - Webcam
 - Headphones with microphone
